CEO REMARKS

Last year I ended my CEO Remarks with 'Let's do it B.I.G', this was more than just a play on our rebranding from The Barlow Foundation to the Barlow Impact Group. It was setting an intention to have the greatest possible impact we could. To go beyond traditional philanthropy and to constantly strive to do more.

Step one, we employed an Impact Manager. Fergus McKenna, a recent philosophy and law graduate with experience in impact investing approached me interested in taking on the job. I was initially hesitant, as he is also my son, however the fit has been perfect, as he has developed measurement systems, analysis frameworks and generally helped us to clearly define our investments. Through his work Fergus has identified that the true picture of our investment portfolio is 58.40% impact, 32.49% ESG/Sustainable. 6.69% traditional and 2.29% in cash.

So this has motivated us to work harder and to find more opportunities to move those investments to reach our stated goal of being 100% impact invested.

Step two, we have begun the process of measuring our investments against the SDG's thus ensuring we are participating in the movement of capital towards reducing inequalities and 'to achieve a better and more sustainable future for all'.

Step three, we have refined our granting process. We set up a new online application process and awarded fewer, larger and untied grants to those working towards true systems change. Our \$1 million B.I.G CHANGE winner From The Heart is seeking a referendum to enshrine an Indigenous voice to Parliament in the constitution. The younger members of the Barlow Family chose Beyond Zero as their B.I.G. FUTURE grant winner, a climate change think tank producing research on how to transition advanced economies to a zero emissions model. Both initiatives have enormous potential to produce life changing impact.

We had another year where we honoured the values established by our founder. We maximised our impact, we built on our relationships and we did it all with honesty and integrity. But mostly, just as Bev would have wanted, we loved every minute of it.

It has been once again an honour, and I look forward to steering the team towards growth and greater impact in the years ahead.

In 2020/21 we granted \$1,045,019 to the following changemakers who are working to reduce inequalities in the Asia-Pacific region.



B.I.G.CHANGE



\$150,000 over the past three years provided lawyer salaries for ASRC's Gender Clinic in their Human Rights Law Program. Providing access to justice services for asylum seekers facing gender and sexuality-based discrimination.



\$750,000 over the past five years to the Rainbow Pride Foundation to engage with Faith-based leaders to address issues of discrimination against the LGBT+ communuity in Fiji. The grant further supported socio-economic and leadership development of rural women, creating an e-commerce platform that provided offshore market opportunities to support women's artisanry.



VFBV VOLUNTEER FIRE BRIGADES VICTORIA **\$432,000 over five years** supported 138 Australian female students living in disadvantage through the 'Learning for Life' program. This included financial and personal support, and additional learning and mentoring programs.

"I alone cannot change the world, but I can cast a stone across the waters to create many ripples" MOTHER TERESA **\$500,000 over two years** provided grants for CFA volunteers directly impacted by the Black Summer fires to support repairs to their properties. Also four emergency equipment grants to four CFA groups located in the most impacted areas of the 2019/20 fire season. \$100k has been quarantined for future emergency relief.



\$150,000 over three years supported NJP's growth and development program directed towards the fundraising and communications team. Specialist roles has freed up time for the executive, legal, and project teams.



\$190,000 helped produce the Dreams Interrupted and Childhood in Custody series. More articles will follow focusing on Indigenous issues and raising awareness.



\$100,000 to support the Uluru Statement from the Heart, which is an invitation to the Australian people from First Nations Australians, by establishing a Voice to Parliament enshrined in the Constitution.

Human Rights Law Centre

\$75,000 towards establishing Australia's first dedicated legal service to provide expert support and protection to whistle-blowers.




\$75,000 to establish the Beverley Barlow Nursing Grant, which provides scholarships for nurses to increase their skills, in honour of the founder of the Barlow Foundation.



\$70,000 to support the Grata Fund's legal campaigns, including in the fields of climate, democracy, and freedom of information.

Carbon eight ()

\$70,000 to support farmers transitioning to regenerative agriculture by assisting them in rebuilding the carbon (organic matter) in their soil. At Barlow Impact Group we invest to put people and planet first, and create a better world



We are continuing with our 2016 commitment to transition all of our investments to impact investments. This ensures we activate all of our capital to achieve the greatest possible impact. Between 2014 and 2019, the Barlow Impact Group grew ESG and impact investments from 2% to 91%.

A HUB FOR IDEAS TO GROW

At Barlow Impact Group we believe that sharing ideas, information and skills, multiplies impact.

This past year we achieved this by publishing our investment portfolio on our website and its performance for the first time. Our hope is that by being transparent we can inspire others to move toward impact investing.

At our office in South Melbourne, on the lands of the Bunurong people of the Kulin Nation, we have meet with leaders in the industry, other philanthropists, impact investment experts and heads of charities, so that we may continue to grow, improve and learn. We have also attended many conferences in person and via zoom.

This year we held our first panel interviews, where the esteemed selection panel of Sarah Davies, Reverend Tim Costello (AO), Daniel Madhavan and Kate Kennedy met with finalists for our \$1 million B.I.G CHANGE prize. They spent 45 minutes to 1 hour with each of the nine finalists before coming to a unanimous decision in choosing our winner.

We also have a two-bedroom apartment, two boardrooms, a studio, office and function spaces available, which our charity partners utilise as needed.
